

# How your councils work

There is a variety of different types of council in England; together they form what is known as local government. In West Suffolk there is:

- a county council <u>Suffolk County Council</u>
- a district council West Suffolk Council

Each type of council has responsibility for providing different services to residents, community groups, visitors and businesses alongside a wider set of more strategic responsibilities. These customer-facing services are set out below.

Waste and recycling	Rubbish collection, recycling and the garden waste collection service for residents and businesses. - bus shelters
- cemeteries
- footpaths
- open spaces
- village spaces.

The majority of affordable housing in West Suffolk is provided by <u>Havebury Housing Partnership</u> and <u>Samphire Homes</u>.
